

## **General Terms and Conditions – [OFFER HIGHLIGHT]**

### **Introduction:**

- i. The following terms apply, for a limited period, between all participants and World First UK LTD (“World First”) in conjunction with Institute of Directors (“IoD”) to provide members with a £30 Voucher (the “Voucher”) towards one personal international money transfer with World First per calendar month (the “Offer”);
- ii. By accepting this Offer, you are agreeing to the following Terms and Conditions:

### **The Offer:**

- i. This offer entitles IoD Members only to a £30 Voucher to be used towards one personal international money transfer with World First per calendar month.
- ii. Valid until 31<sup>st</sup> December 2019
- iii. You will need to open an account with World First and place a trade of £1,000 or more (or equivalent currency) in order to qualify.

- v. For the avoidance of doubt, this Voucher is only applicable towards a FX transaction with a minimum sale currency value of £1,000 with World First and cannot be exchanged for cash.
- vi. The promotion codes must be applied to a foreign exchange transaction with a GBP sale currency.
- vii. Only one promotion code per member may be redeemed per calendar month and the promotion cannot be used in conjunction with any other offer.
- viii. To use a promotion code, simply enter the appropriate month’s code into the promotion code box on the online trading platform, or quote the offer and the code to your dealer over the telephone. The currency trade value before entering the promotion code must be £1,000 or more.
